

Terms & Conditions Contest for Ignite Innovation In Your Organization Event

1. The promoter of the " Ignite Innovation In Your Organization event " contest (the "**Contest**") are Dell Global Business Center (a member of Dell Technologies Group of Companies), Intel and PERJASA (the "**Promoter**").
